

INVESTMENT OBJECTIVE


The 3B BCI Prudential Fund of Funds is a prudential managed fund of funds. The objective of this portfolio is to provide the investor with a high long term total return.

INVESTMENT POLICY

The portfolio will invest in a broad range of participatory interests and other forms of participation in collective investment schemes or similar schemes. Investments to be included in the portfolio will, apart from assets in liquid form, consist solely of participatory interests in portfolios of collective investment schemes investing in equity securities, property shares, property related securities, non-equity securities, bonds, preference shares, interest bearing securities, derivatives and money markets instruments. The portfolio's equity exposure should, on average, vary between 0% and 75% of the portfolio's net asset value.



RISK PROFILE



Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a medium risk portfolio, but less than a high-risk portfolio. The probability of losses is higher than that of a medium risk portfolio, but less than a high-risk portfolio and the expected potential long-term investment returns could therefore be higher than a medium risk portfolio.
