

INVESTMENT OBJECTIVE

The **Anchor BCI Diversified Moderate Fund** is a multi-managed portfolio with a moderate risk profile that aims to provide investors with a moderate long-term total return. This Fund is appropriate for clients who want exposure to Anchor's capabilities in a solution that is appropriately blended and diversified with other offerings to ensure a more consistent return profile.

INVESTMENT PHILOSOPHY


The portfolio will be managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act. The portfolio's equity exposure is limited to a maximum of 60% of the portfolio's net asset value. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money-market instruments, interest-bearing securities, bonds, debentures, corporate debt, equity securities, other interest-bearing securities, property securities, preference shares, convertible equities and non-equity securities. The portfolio may, from time to time, invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions for efficient portfolio management purposes.




RISK PROFILE: MODERATE

FUND MANAGER COMMENTARY AT 31 OCT 2025

October once again cast its spell over global markets, with equities climbing higher under the eerie glow of optimism. Yet beneath the surface of this seemingly enchanted rally, some unsettling murmurs emerged — narrowing leadership, rising rate tension, and macro headwinds that hint not all is calm in the dark corners of the market. In the US, the monsters of market cap — the "Magnificent Seven" — continued to dominate, casting long shadows over smaller names. Additionally, the US Federal Reserve (Fed) brewed its own potion, trimming rates by 25 bps to a range of 3.75%–4.00%. Across the globe, Europe's markets edged marginally higher while Japan staged a powerful revival. China's markets, by contrast, remained haunted by growth worries despite a faint glimmer of relief from a modest US–China trade truce. Closer to home, South Africa's (SA) inflation crept to 3.4% YoY in September, still floating above the SA Reserve Bank's (SARB) new 3% proposed target. Although markets price a slight chance of a rate cut in November, the SARB seems unlikely to cast an early-easing spell just yet. Despite this, JSE-listed equities added a touch of Halloween cheer as financials and property rose from the grave to deliver gains, while resources took a brief breather. October's rally may have looked fearless, but markets remain a haunted house of data — each new inflation print or policy comment capable of making investors jump. Staying calm amid the creaks and shadows will matter most as we head toward year-end, where both treats and tricks may still await. Although the portfolio lagged its benchmark and peers, due to being underweight global equities, the returns were above expectations, which was driven by the local bond market.
