

INVESTMENT OBJECTIVE

The **Anchor BCI Equity Fund** is a general equity portfolio that seeks to sustain high long-term capital growth.

INVESTMENT PHILOSOPHY


The portfolio is constructed from bottom-up, fundamental research with an investment philosophy that favours quality stocks with superior returns on capital, cash flows and pricing power. While acceptable valuation is an important component of the stock-selection process, the fund's style is not "value" – investments will be made in premium-rated stocks where the growth outlook and quality profile warrants it. The fund will also own shares that are often not well researched, yet offer exceptional valuation-driven opportunities. The quality of companies included is judged by rates of earnings growth, return on capital employed, cash conversion and stability of margins. The portfolio may, from time to time, invest in listed and unlisted financial instruments. The manager may include the following unlisted financial instruments: forward currency, interest rate and exchange-rate swap transactions for efficient portfolio management purposes. The portfolio's equity exposure will always exceed 80% of the portfolio's net asset value.



- Therefore, it is suitable for long term investment horizons.


FUND PERFORMANCE AT 31 OCT 2025 (%)

FUND MANAGER COMMENTARY AT 31 OCT 2025

The Anchor BCI Equity Fund was up 0.8% in October, bringing its YTD return to 26.0%. The JSE recorded its eighth consecutive monthly advance in October; however, in stark contrast to the past few months, commodity-linked shares were the underperformers (Resi-10 -5.4% MoM/+104.8% YTD), marking their first monthly decline since February. Although the fund's underweight exposure to miners helped its relative performance, holdings in Impala Platinum (-15% MoM) and Harmony (-8% MoM) detracted from absolute returns. We Buy Cars (-17% MoM), whose trading update fell short of market expectations, was also a notable detractor. On the positive side, there were clear signs of a rotation into so-called SA Inc. shares as the month progressed. Boxer (+10% MoM) delivered a solid set of results, underscoring its store rollout plans. Some progress in the requirements for "university status" in South Africa supported ADVTECH (+12% MoM). Discovery (+11% MoM) also announced an upbeat quarterly trading update. During the month, we increased our banking exposure through Standard Bank and Absa, reflecting our view that banks remain attractively valued relative to bond yields. Elsewhere, we exited Investec as its latest trading update suggests subdued prospects. Over the course of the month, we made no changes to the international holdings of the fund. The fund's core holdings remain quality compounders, which we seek to augment by looking for shorter-term opportunities.
