


INVESTMENT OBJECTIVE

INVESTMENT POLICY

Investments to be acquired for the portfolio may include bond, money market instruments and other interest earning securities. The portfolio's equity exposure may be as high as 10% of the portfolio's net asset value. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions.


