


INVESTMENT OBJECTIVE

The BCI Contrarius Global Equity Feeder Fund aims to earn a higher total rate of return than the average of the world's equity markets, as represented by the MSCI World Index, including the reinvestment of dividends net of withholding tax ("MSCI World Index"). It aims to achieve this without greater risk of loss, over the long-term.

INVESTMENT POLICY

The portfolio will, apart from assets in liquid form, invest solely in Fixed Fee Class shares of Contrarius Global Equity Fund, a sub-fund of Contrarius ICAV, domiciled in Ireland. Contrarius Global Equity Fund is an actively managed fund that aims to be substantially invested in selected global equities and equity related securities at all times and thus be exposed to all the risks and rewards of the global equities selected in the portfolio. These equities are selected using proprietary investment research and by applying Contrarius' long-term, contrarian, valuation-based investment philosophy. The Contrarius Global Equity Fund does not seek to replicate the benchmark and its equity holdings may differ materially from the benchmark in order to achieve its objective. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.



High Risk

- The portfolio has a high exposure to derivative instruments, which may carry additional risks.


