
INVESTMENT OBJECTIVE

INVESTMENT POLICY



The underlying portfolios invests primarily in equity securities. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.
