INVESTMENT OBJECTIVE

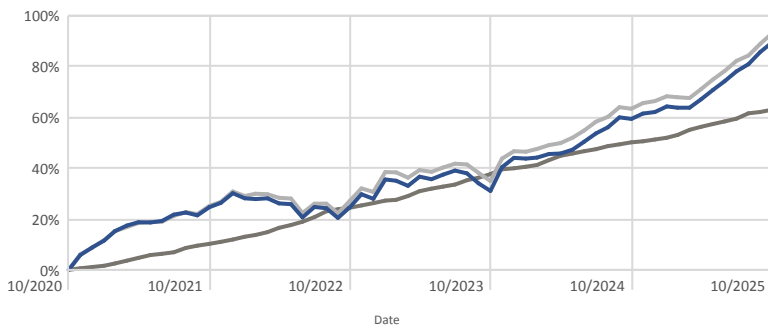
The Bovest BCI Managed Fund of Funds is a managed prudential fund of funds portfolio seeking to deliver moderate long-term capital growth with a moderate level of income.

INVESTMENT POLICY

Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, which is consistent with the portfolio's primary objective, investing in amongst others, equity securities, property securities, non-equity securities, interest bearing securities, money market instruments, preference shares, bonds and other interest-bearing instruments and securities. The portfolio's equity exposure, on a look through basis, will range between 0% and 75% of the total portfolio net asset value.

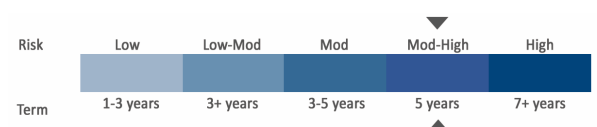

Moderate - High Risk
