

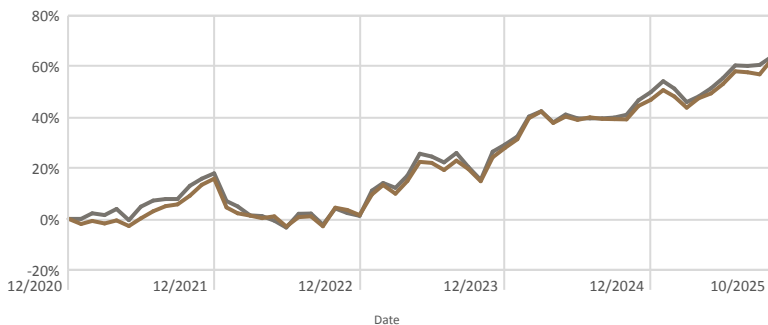
INVESTMENT OBJECTIVE

INVESTMENT POLICY

The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the Brentthurst Global Equity Fund IC Limited, an incorporated cell under the IPFM Guernsey ICC Limited, domiciled in Guernsey. The underlying portfolios invest primarily in global equity securities. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

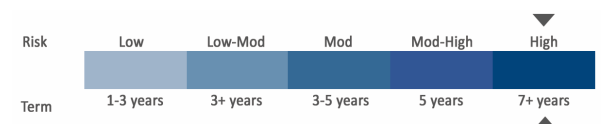

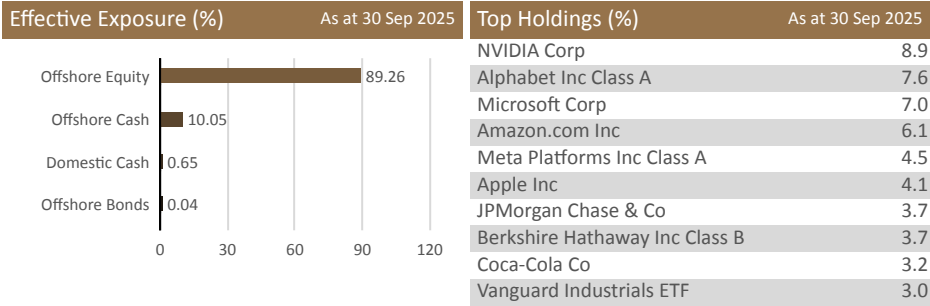
High Risk
