

INVESTMENT OBJECTIVE

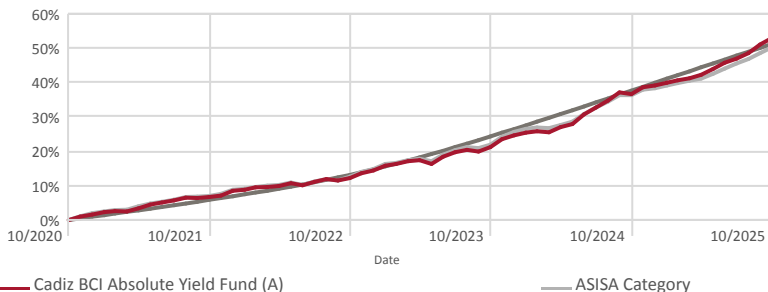
The objective is to provide investors with a diversified exposure to the South African bond market and aims to offer a balance between capital growth and income for a maximum overall return.

INVESTMENT POLICY

The portfolio uses aggressive duration positioning, active credit and other yield enhancement strategies to maximize returns. The portfolio invests across the full spectrum of the yield curve. The composition of the underlying investments is actively managed and will change over time to reflect the current assessment of interest rate trends. The portfolio focuses on yield enhancement by investing in sector bonds, as well as non-government bonds. Investments to be acquired for the portfolio may include property securities, property related securities, interest bearing securities and instruments, non-equity securities, money market instruments, preference shares, derivatives and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

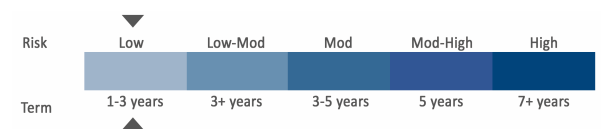

- The portfolio is suitable for shorter term investment horizons.

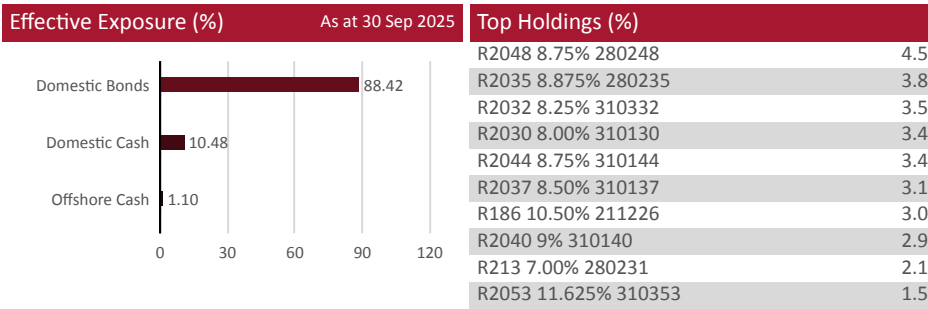
