### INVESTMENT OBJECTIVE

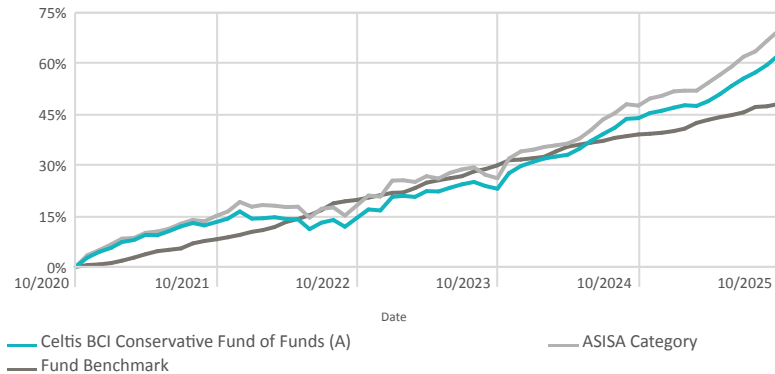
The primary investment objective of the portfolio is to provide the investor with a high level of income and stable capital growth.

The primary investment objective of the portfolio is to provide the investor with a high level of income and stable capital growth, and will seek to follow an investment policy which will reflect a spread of investments aiming at income and capital growth normally associated with the investment structure of a retirement fund with a cautious risk profile.

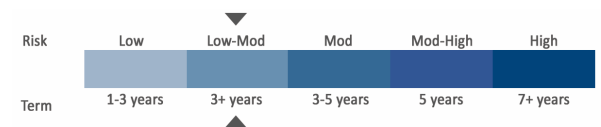

### RISK PROFILE



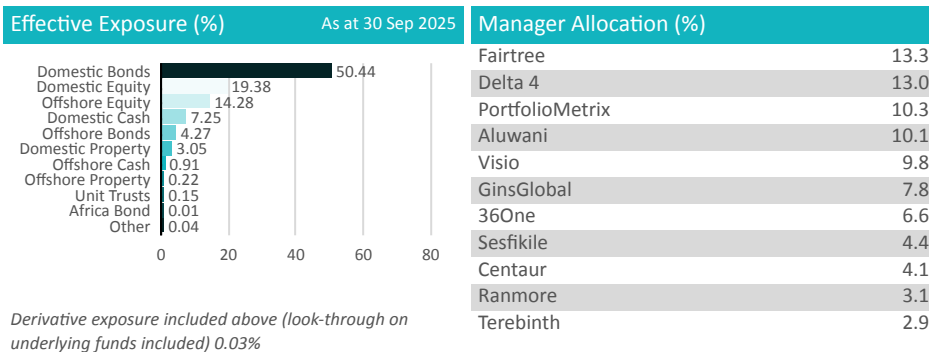
#### Low - Moderate Risk
