INVESTMENT POLICY

The portfolio may invest in global and local equity securities, government -, corporate- and inflation linked bonds, debentures, non-equity securities, property shares, property related securities, preference shares, money market instruments and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instrument. The manager may also include forward currency, interest rate and exchange rate swap transactions for efficient portfolio management purposes.

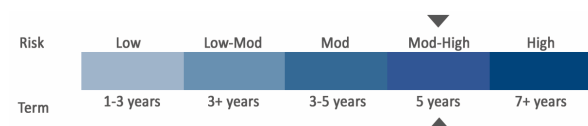
