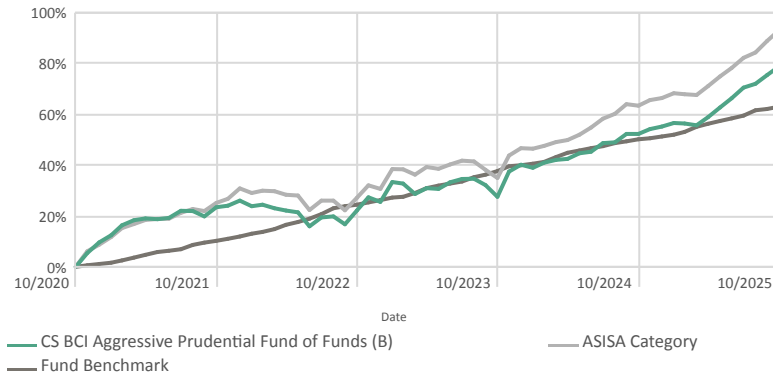
The objective of this portfolio is to provide the investor with a relatively high long term total return whilst complying with prudential investment guidelines.

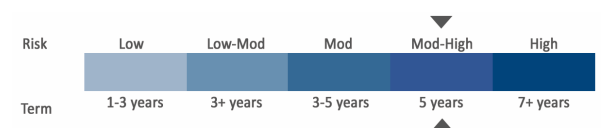

Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
