

INVESTMENT OBJECTIVE

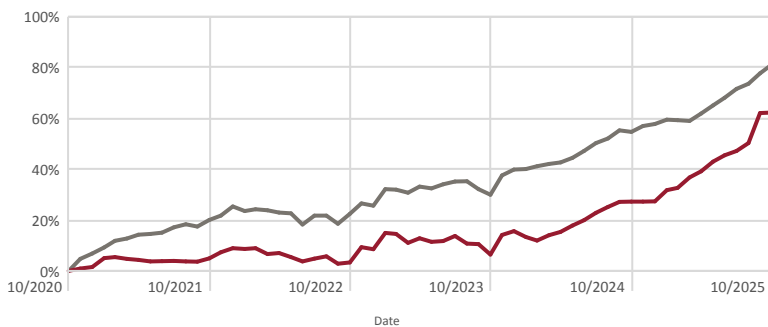
The Fund aims to achieve moderate capital appreciation with reasonable volatility within the prudential asset allocation constraints.

INVESTMENT POLICY

The asset allocation of the portfolio varies according to the investment manager's macroeconomic outlook views as well as the attractiveness of each asset class. The investment manager has complete flexibility to vary the exposure to different asset classes as economic conditions changes. The portfolio's net equity exposure ranges between 0% and 60% of the portfolio's net asset value. The investments to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities and non-equity securities. The manager may invest in participatory interests or any other form of participation in portfolios of collective investment schemes.

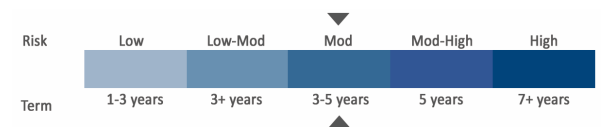

Moderate Risk

- This portfolio has a balanced exposure to various asset classes. It has more equity exposure than a low risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a low risk portfolio, but less than a high-risk portfolio.
- Where the asset allocation contained in this MDD reflects offshore exposure, the portfolio is exposed to currency risks.
- The portfolio is exposed to equity as well as default and interest rate risks.
- The portfolio is suitable for medium term investment horizons.
