

INVESTMENT OBJECTIVE


The Fund's objective is to maximise the current level of income while providing high capital stability and predictable income distributions.

INVESTMENT POLICY

The portfolio aims to achieve performance returns in excess of money market and current account yields. The portfolio's maximum equity and property exposures will not exceed 10% and 25% of its net asset value respectively. Investments to be acquired for the portfolio may include equity securities, property securities, property related securities, interest bearing securities, non-equity securities, money market instruments, preference shares and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.


