

INVESTMENT OBJECTIVE

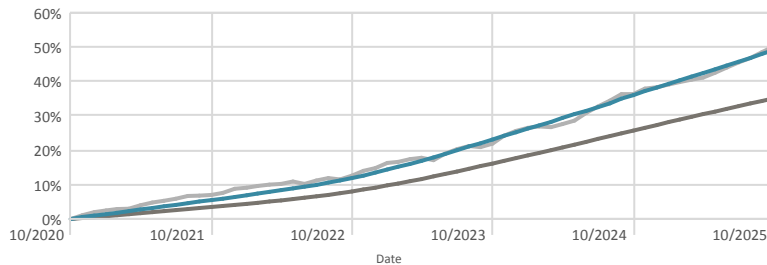
The Instiit BCI Flexible Income Fund is an income generating portfolio with the objective to maximise its income yield with the flexibility to invest in a diverse range of mainly interest bearing instruments.

INVESTMENT POLICY

The portfolio invests in high risk interest bearing instruments, however, the riskiest instruments to be acquired will not be rated below "non-investment grade speculative". The manager will actively manage the portfolio's interest rate risk exposure to ensure that the portfolio's volatility remains low except for in case of credit defaults or a substantial widening in credit spreads during adverse market conditions. Currency hedges may be applied to substantially offset the impact of movements of the Rand relative to offshore currencies. The portfolio's equity exposure may be as high as 10% of the portfolio's net asset value, whilst the property exposure may be as high as 20%. The portfolio may from time to time invest in listed and unlisted financial instruments such as forward currency, interest rate and exchange rate swap transactions.

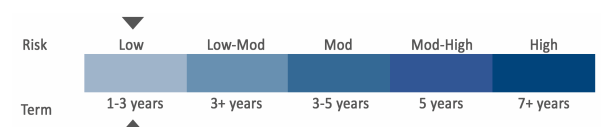

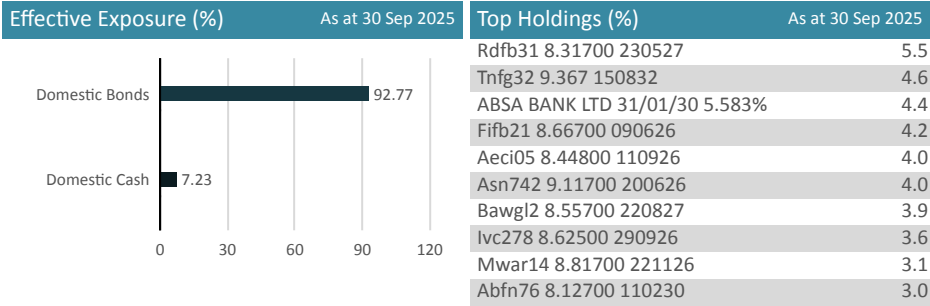
Low Risk
