

INVESTMENT OBJECTIVE

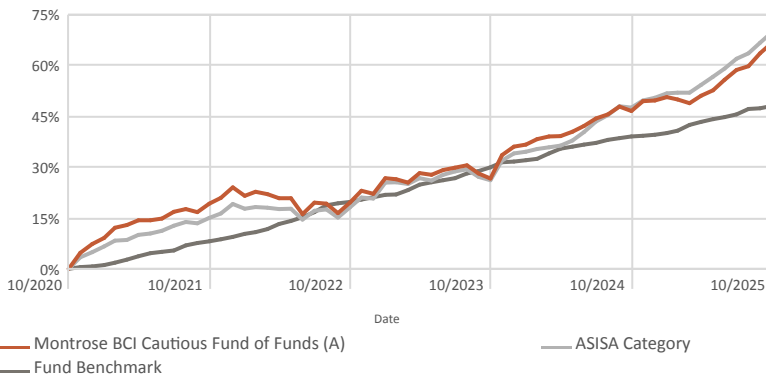

INVESTMENT POLICY

The Montrose BCI Cautious Fund of Funds is a specialist portfolio with the objective to secure consistent real total returns in excess of inflation plus 3% p.a. over any rolling 3 year period. In selecting underlying portfolios for this portfolio and in determining the portfolio asset allocation, the manager shall seek to achieve this objective, where possible, regardless of stock market trends.

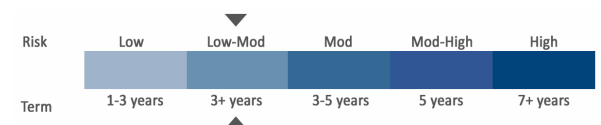

RISK PROFILE



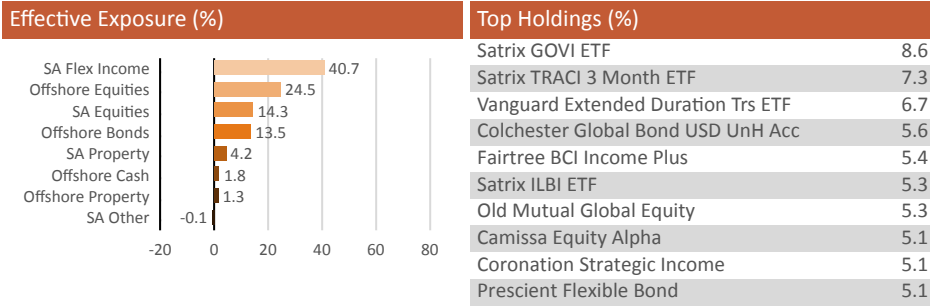
Low - Moderate Risk
