

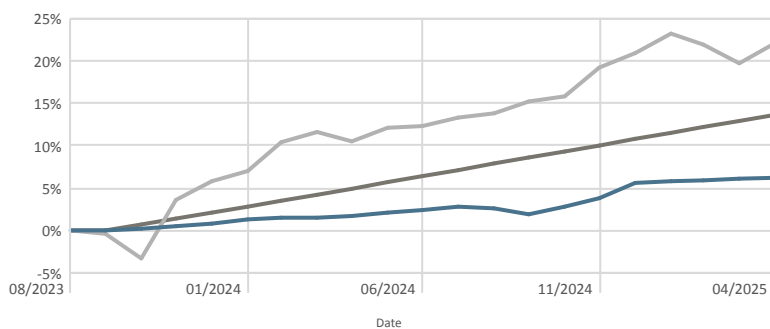
INVESTMENT OBJECTIVE

The Providence BCI Worldwide Flexible Income Fund is an income generating portfolio with the objective to deliver a high level of sustainable income and stability of capital invested.

INVESTMENT POLICY

The portfolio's investment universe includes global and local equity securities, government bonds, corporate bonds and inflation linked bonds, debentures, property securities, property related securities, interest bearing securities, preference shares, money market instruments and assets in liquid form. The portfolio's maximum equity exposure is 30% of the portfolio's net asset value. The portfolio may invest in participatory interests and other forms of participation in portfolios of collective investment schemes, registered in South Africa and other similar schemes operated in territories with a regulatory environment. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may include forward currency, interest rate and exchange rate swap transactions.

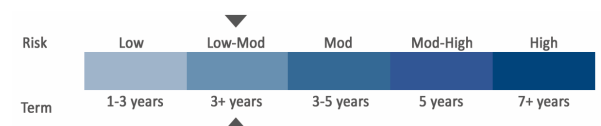

- The expected potential long-term investment returns are lower but less volatile over the medium to long term than higher risk portfolios.

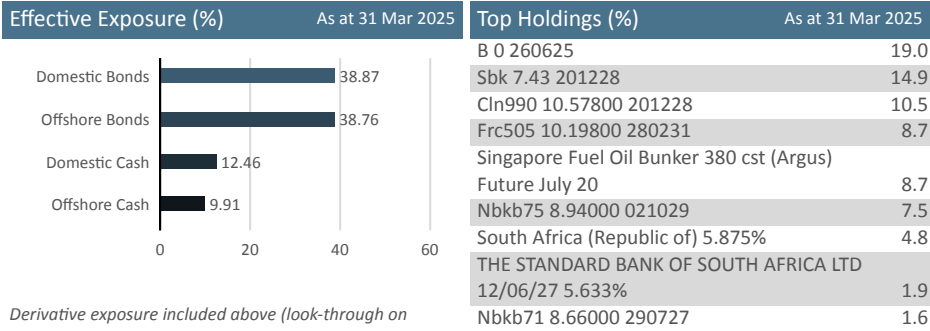
