RISCURA BCI CHINA EQUITY FEEDER FUND (A)

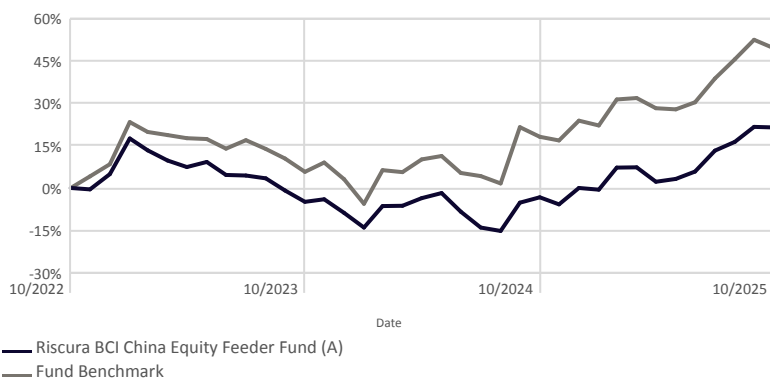
INVESTMENT OBJECTIVE

The Riscura BCI China Equity Feeder Fund aims to provide investors with a long-term capital growth.

INVESTMENT POLICY

The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the Riscura China Equity Fund, a fund of the Prescient Global Funds ICAV, domiciled in Ireland. The underlying portfolio's investment objective is to gain exposure to Chinese equities and equity-related securities on a direct and or indirect basis. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

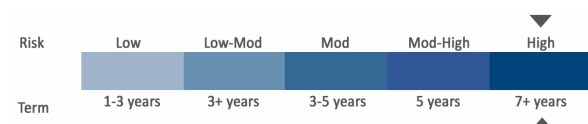

High Risk
