

INVESTMENT OBJECTIVE

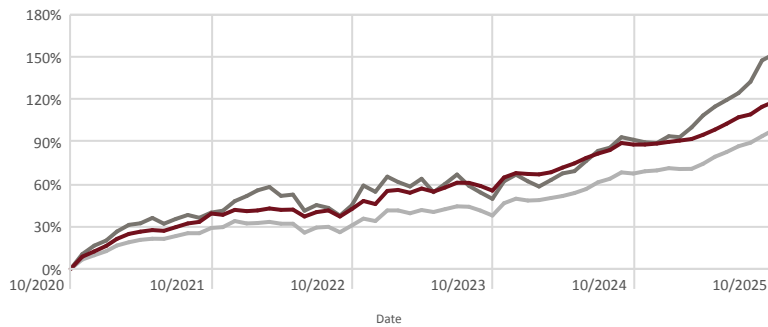
The Salvo BCI Dynamic Flexible Fund is a flexible portfolio that aims to maximise total returns over the long term with the risk of greater short-term volatility of capital values.

INVESTMENT POLICY

In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities and instruments, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. The portfolio may from time to time invest in listed and unlisted financial instruments.

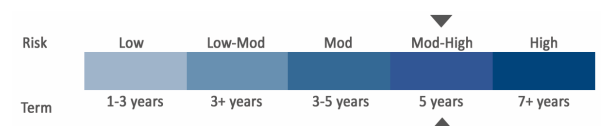

RISK PROFILE



Moderate - High Risk
