


INVESTMENT OBJECTIVE

The objective is to generate income and moderate capital growth over the medium to long term.

INVESTMENT POLICY

The Fund may invest in a broad range of local and international asset classes, using primarily factor based as well as other passive and enhanced index investment strategies. Factor strategies to be applied may include factors such as growth, momentum, quality and value. The portfolio's asset allocation will be determined by applying a top-down approach influenced predominantly by long term asset class risk premia and macro-economic considerations, as well as a bottom-up approach influenced predominantly by fundamental asset class valuations, across a broad range of well-considered valuation criteria. Based upon input from this top down and bottom up framework, the manager will apply their prudent discretion to determine the most optimal long term strategic as well as tactical asset class positioning for the portfolio. The portfolio will be subject to maximum equity exposure of 40% of the portfolio's net asset value. The portfolio may from time to time invest in listed and unlisted financial instruments, as well as listed and unlisted instruments.


