## INVESTMENT OBJECTIVE

The Sequoia BCI Managed Growth Fund of Funds aims to deliver a moderate level of income combined with moderate to high long-term capital growth.

## INVESTMENT POLICY

The portfolio will have investment instrument exposure across multiple asset classes in order to ensure portfolio diversification and therefore risk reduction. On a look through basis, the portfolio's equity exposure will range between 0% and 75% of the its asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consists of participatory interests and other forms of participation of local and global collective investment schemes, investing in amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.




