

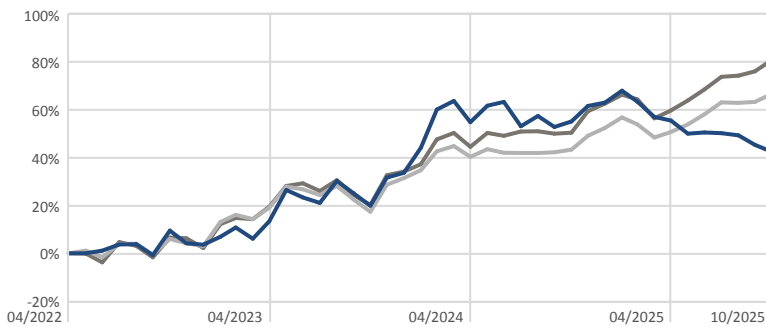
INVESTMENT OBJECTIVE

The Southern Right Capital BCI GQG Global Equity Feeder Fund aims to provide investors with long term capital growth.

INVESTMENT POLICY

The underlying portfolio seeks to invest in high-quality companies with attractively priced future growth prospects in both developed and emerging markets. The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the GQG Partners Global Equity Fund, a sub-fund of the GQG Global UCITS ICAV, domiciled Ireland. The underlying portfolio invests primarily in equity securities. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

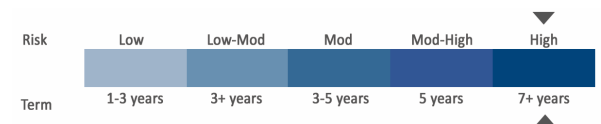

- The portfolio has a high exposure to derivative instruments, which may carry additional risks.

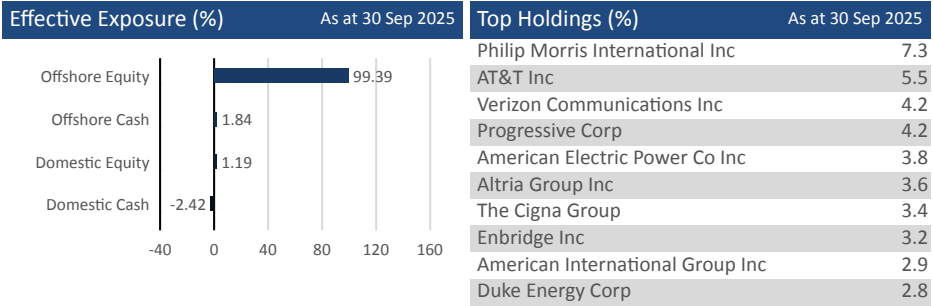
