


**INVESTMENT OBJECTIVE**

The Visio BCI SA Opportunities Fund is a domestic general equity portfolio that aims to provide investors with high long-term capital growth.

**INVESTMENT POLICY**

The portfolio is managed as a benchmark agnostic, high conviction portfolio with a focus on long term investment opportunities derived from mostly, but not exclusively, the mid and small cap space. The portfolio's net equity exposure will be a minimum of 80% of the portfolio's asset value. The portfolio's investment universe consists of South African equity securities, preference shares, property shares and property related securities, notes, non-equity securities, interest bearing instruments and securities as well as assets in liquid form. The portfolio may invest in participatory interests and other forms of participation in portfolios of South African collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.




**High Risk**
