

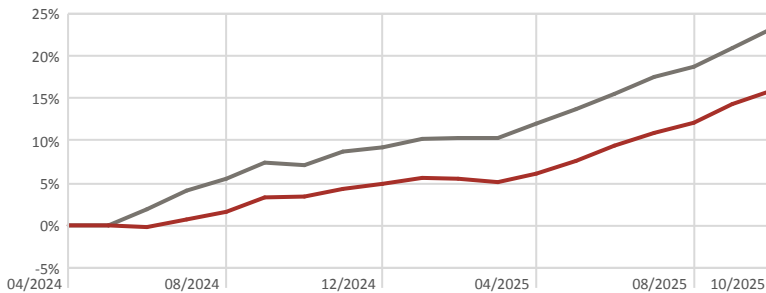
## INVESTMENT OBJECTIVE

The Wealth Creators BCI Cautious Fund of Funds aims to deliver a stable level of income combined with long term capital stability.

## INVESTMENT POLICY

Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment. The investments will be in consistent with the portfolio's primary objective, investing in equity securities, property and property related securities, notes, non-equity instruments and securities, money market instruments, financial instruments, bonds and other interest-bearing instruments and securities. The portfolio's equity exposure may be as high as 40% of the portfolio's net asset value.

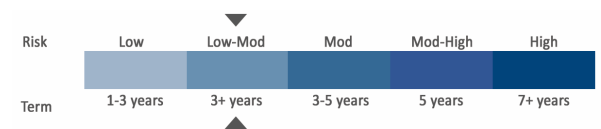
