

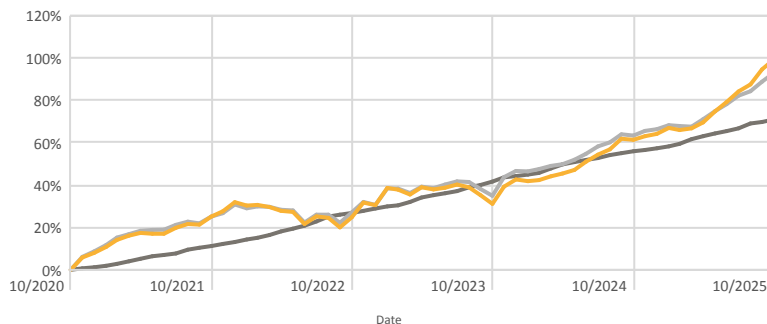
INVESTMENT OBJECTIVE

The objective is to offer investors a moderate to high long-term total return with a focus on investment growth by investing across asset classes. The portfolio aims to achieve a return of 6% above inflation over rolling 7-year periods.

INVESTMENT POLICY

The portfolio's net equity exposure will range between 0% and 75% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes. The investments will be consistent with the portfolio's primary objective, investing in equity securities, property and property related securities, non-equity securities, money market instruments financial instruments, bonds and other interest-bearing instruments and securities.

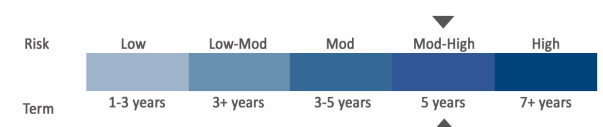

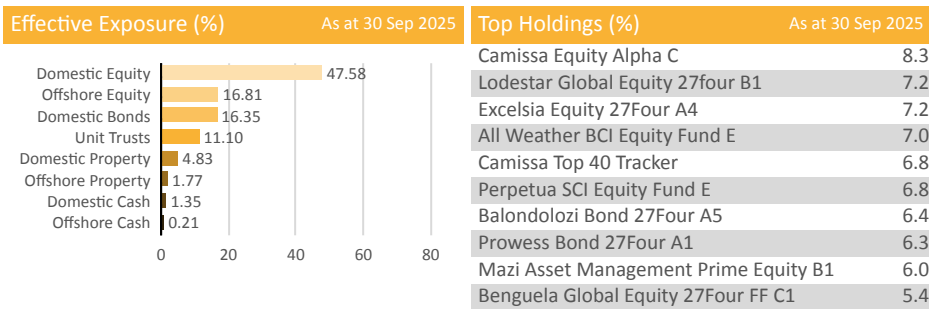


Moderate - High Risk
